




## 2024-25 GRANDPARENT ESSAY CONTEST

#### **Purpose**

- Honoring the role grandparents play
- Bring attention to number of students being raised by grandparents
- Educate principals and teachers about challenges of these students and grandparents
- Gain community service credit for participation









#### **JUDGING CRITERIA**

50% Qualifying characteristics of nominee as a grandparent

30% Creativity & Expression

20% Grammar, Form, & Neatness

#### **CONTEST DEADLINES – ENTRIES TO AARP BY THESE DATES**

School winners: December 15, 2024

County winners: January 31, 2025

District winners: March 1, 2025

State winner announced at the KRTA Annual Meeting in April 2025.



#### **TECHNICAL REQUIREMENTS**

- Original work of the author
- Essay must be written about one and only one grandparent or surrogate grandparent who is alive at the time the essay is written
- **NEW:** Teachers and Schools can choose a handwritten or digitally typed criteria optional requirement for essay submission:
  - a. 300-500 words in length, handwritten in English on one side only on white, lined 8"x11" paper; a copy of the original may be submitted OR
  - b. 300-500 words in length, digitally typed in English on one side only on white, double-spaced 8"x11" paper; a digital copy may be submitted
- Include the components of a formal essay, e.g., introduction, supporting points, and conclusion
- Name and school of the author must be written or typed at the end of the essay
- Remember: teachers must submit school winner form ONLINE (to AARP) in addition to providing a
  paper form & handwritten essay OR digital typed copy of essay to local RTA

#### **AWARDS** – Funding of cash awards has increased!

- School winner: Certificate to student each participating school
- County winner: upgraded Certificate with embossed writing/decor
- District winner: Plaque and \$100 award (\$50 increase from past years)
- State winner: Plaque, \$500 award, expense paid trip to KRTA Convention for state winner & grandparent (\$400 increase, plus increased travel funds for grandparent)
- \$500 for winning student's teacher for school supplies (\$350 increase)
- Two \$250 drawings for school supplies for all participating teachers (\$350 increase)

# 2024 KENTUCKY GENERAL ASSEMBLY: UPDATE MAKING LIFE MORE AFFORDABLE

- \$10,000,000 more each fiscal year for the expansion of the Senior Nutrition Assistance Program.
- •250 slots (first fiscal year) and 500 slots (next fiscal year) for Home and Community Based Service Waivers.
- •125 slots-(first fiscal year) and 250 slots (next fiscal year) for Supports for Community Living.
- •Increased the nursing home residents' Personal Needs Allowance from \$40 a month to \$60 a month per person.
- •\$1,444,600 increase for the Long-Term Care Ombudsman program.
- •Increasing monthly Personal Needs Allowance for Medicaid recipients in nursing homes from \$40 to \$60.
- •Prohibiting some predatory real-estate fee agreements for consumers.
